The Group has conducted a restructuring of shareholding structure since 2014, to reinforce the Group’s business in Hong Kong and facilitate development in China and overseas together with CCCG Group. Riding on the advantages from the consolidation of network and resources from China and Hong Kong, the Group will continue to strengthen its construction, property development and property management businesses, while expanding business scope into construction management, project consultancy, construction finance, investment and financing, in Hong Kong, China and overseas markets.

Chun Wo Development Holdings Limited

Chun Wo Development Holdings Limited (“Chun Wo”) was founded in 1968 and initially was engaged in the construction business. In 1993, Chun Wo was listed on the Main Board of the Hong Kong Stock Exchange under the name of “Chun Wo Holdings Company Limited”. As its businesses have expanded beyond construction to property development and property management, the company subsequently changed the company name to “Chun Wo Development Holdings Limited” in 2007. In 2015, Chun Wo introduced strategic shareholders, China New Way Investment Limited and China City Construction Holding Group Company to leverage the company’s network and resources in China aimed at expanding the business overseas implementing the "Going Out" integrated business strategy. In February 2016, the listed name “Chun Wo Development Holdings Limited”, has been changed to “China City Construction Group Holdings Limited” (“the Group”) (stock code: 00711) in order to enhance the Group’s corporate image and better prepare to seek greater international development opportunities.
