Chun Wo Corporate Social Responsibility Programme involved in 3 main areas: volunteer services, caring for staff's family and donations. The Chun Wo Volunteer Team was formed in 2004 with the aim of elaborating the Group's spirit in serving the community. The team has around 40 volunteers who actively participate in different community and charity services. In 2005, the team co-operated with Tung Wah Group of Hospitals Shuen Wan Complex for the Elderly at Tai Po and the Social Welfare Department on a safety and rehabilitation programme for about 60 elderly in Tai Po remote villages. The volunteers visited the elderly in Tai Po remote villages on every Saturday for teaching the home safety knowledge and providing slippage preventive and maintenance services. This would prevent the injuries caused by slippage of elderly at home. Furthermore, the volunteer team also participated in the "Christmas Decoration Day" for the elderly homes in Kowloon City, "Sowers Action" fund raising charity day and selling cookies for "Haven of Hope" etc.
